- ⑪ HVAC is AC units without fresh air intake
- ⑫ AC units without outdoor air intake
- ⑬ Not applicable
- ⑭ Limited air changes without outdoor air intake in systems
- ⑰/⑱ Concerns about power capacity of buildings if fans and HEPA filters are used
- ⑳/㉑ Have not yet identified specific room to use for isolation room; considering use of one of the classrooms or communal rooms that will not otherwise be utilized
- ㉒ Building still has construction projects; will implement ~~the~~ measures (e.g. tape) once completed
